- Budget Updates & Proposed Adjustments

All budget lines have been updated with BOFC-approved shifts and appropriations. To bring all expense lines into compliance, the following are proposed:

- a. Transfers

- i. 34101.1 Overtime is overspent by \$17,835.86 – transfer \$30,000 from 34101.0 Career Wages to cover remaining payrolls – **APPROVED.**
- ii. 341018.2 Fire Prevention Personnel is overspent by \$156.61 – transfer \$1,000 from 34101.0 Career Wages – **APPROVED.**
- iii. 1506.1 Medical/Physical – transfer \$5,000 from 90608 Health Insurance – Career to cover the remainder of 2025 – **APPROVED.**

- b. Appropriations

- i. 1200.1 Building Maintenance Supplies – appropriate \$2,000 from Interest Earnings to cover the overage and the remainder of 2025.
- ii. 1300.7 Tools – appropriate \$1,000 from Interest Earnings to cover the remainder of 2025.
- iii. 1505.1 Goodwill – appropriate \$1,000 from Interest Earnings to cover the remainder of 2025.
- iv. 1508.12 – appropriate \$3,000 from Interest Earnings to cover the remainder of 2025 – **ALL APPROVED.**

2. 2025 Audit

Sean Hucko and his team will be onsite November 4, 2025 to begin preliminary 2025 audit fieldwork. An update will be provided at the next Commission meeting.

3. Facilities – Fence Project

The fence project is expected to begin soon; permits are in process.

4. Insurance Dividend Receipts

Operations Report

Chief Metcalfe and Assistant Chief Boehl

1. FEMA AFG Grant - Turnout Gear

Due to the ongoing Federal Government shutdown, finalizing the FEMA AFG Grant process for Turnout Gear has been challenging. Despite this, we continue to move forward and expect to have bids ready for BOFC review at the November 17, 2025 meeting.

2. Front Sign - Culver Station

The existing front sign at the Culver station has been removed, and the area has been cleaned and prepped for paint. According to Captain Serenati, Skylight Signs does not anticipate requiring additional electrical infrastructure. Next steps are painting and sign installation within the next few weeks.

3. Crew Sense Scheduling Platform

Historically, Vector Solutions provided our scheduling (Crew Sense), LMS (TargetSolutions), and inventory control (Check-It). We have since transitioned the LMS to Fire Engineering and inventory control to First Due.

4. Currently, we are experiencing recurring system failures with Crew Sense regarding payroll calculations, specifically compensation bank accruals. Multiple attempts to resolve these issues through Vector's ticket system have been unsuccessful.

Rodd has scheduled a meeting/call with Vector to attempt to resolve the issues. Crew Sense's agreement sunsets in March 2026 and requires 60 days written notice to discontinue. We recommend transitioning away from Crew Sense. We are in the process of implementing First Due Scheduling, with the goal of running both systems in parallel during the transition period.

5. Injury Reporting Forms Update

We are updating our injury reporting forms (Non-Service Connected, Workers' Compensation, and 207-a). Our current forms are outdated and create confusion for both employees and administrative staff. We have requested sample forms from Monroe County Career Chiefs and will formalize updated district versions in the coming weeks.

6. General Orders / SOG Development

No new General Orders for this meeting. We are beginning the process of transitioning toward SOGs (Standard Operating Guidelines). Attached is a draft of "Strategies and Tactics for Structure Fires - Residential."

7. Laborer / Mechanic Assistant Recruitment

The new job posting has been drafted and is under review. Once approved, we will move forward with advertisement.

8. We would like to send six (6) members of the IFD for training at the FDIC in Indianapolis in April for an initial cost of \$6,150 - **APPROVED.**

Commission Reports

- *Commissioner Ange (Long Range Planning / Vice-Personnel)*
 - There will be a MCFDOA meeting on 11/20. Commissioners Ange and Napoli will be attending to represent the IFD.
- *Commissioner Ingersoll (BOFC Vice-Chairperson / Buildings & Grounds / LVFA Association Liaison / AFDSNY Rep.)*
 - RCVFA Defensive Driving Class Request
The Ridge-Culver Volunteer Fire Association (RCVFA) has requested use of the Culver Station on February 21, 2026, to host the annual NYS Defensive Driving Class. The Irondequoit Fire District will cover 50% of the course cost for active members, and the RCVFA will cover the remaining 50%.
 - No Alcohol on IFD Property - Policy Clarification and Amendment
Further discussion was held regarding the district's policy prohibiting alcohol on Irondequoit Fire District property. Commissioner Ingersoll reported that the Laurelton Volunteer Fire Association is again requesting special permission to have alcohol in the fire station or picnic area during their monthly meetings and occasional events.
The Fire Chief reiterated that the fire station is a workplace and a public facility, and therefore alcohol is not appropriate or permitted. Although past exceptions may have been allowed, the Chief stated that this can no longer continue.
Commissioner Lipari made a motion to amend General Order #006 to explicitly state that no exceptions will be permitted and that the district's drug and alcohol policy will be rigorously enforced beginning January 1, 2026. The motion was seconded by Commissioner Napoli. Commissioner Ingersoll opposed the motion; the remaining four commissioners voted in favor. The motion passed.
- *Commissioner Lipari (Personnel)*
 - Security Fence Discussion
Discussion was held regarding the new security fence project. The Ridge-Culver Volunteer Fire Association (RCVFA) requested a detailed rendering that clearly shows the areas to be fenced. In addition, the RCVFA asked for written permission to continue using the Culver Station parking lot for events held on their property. They are requesting access through district property to allow full ingress and egress to the 36 Russell Avenue property.
 - Memorandum of Understanding (MOU) Requirement
It was noted that, should access or shared use of the Culver Station parking lot be granted, an appropriate Memorandum of Understanding (MOU) will need to be developed. The MOU must clearly define expectations, including that no alcohol is permitted on any Fire District property, whether inside the building or in outdoor areas such as the grilling space. The Irondequoit Fire District will work with legal counsel to draft the MOU.
 - Following discussion in Executive Session, Temporary Captain Ryan Kohlmeier was promoted to Permanent Captain.
