**RESOLUTION FOR THE EXPENDITURE OF FUNDS
FROM THE CAPITAL RESERVE FUND
FOR THE PURCHASE OF A NEW
2028 PIERCE ENFORCER 105' HEAVY DUTY LADDER QUINT.**

At a duly called meeting of the Irondequoit Fire District held on the 8th day of September 2025, at the Culver Road Fire Station, at which time a quorum of the Commission was present.

On a motion of Commissioner Lipari, seconded by Commissioner Ange, the following Resolution was unanimously adopted:

WHEREAS, the Irondequoit Fire District has established a Capital Reserve Fund for the acquisition of capital improvements and items of equipment pursuant to Section 6-g of the General Municipal Law of the State of New York; and

WHEREAS, this Commission hereby finds that the purchase of a new 2028 Pierce Enforcer 105' Heavy Duty Ladder Quint use is a necessary capital expenditure; and

WHEREAS, the purchase of the foregoing 2028 Pierce Enforcer 105' Heavy Duty Ladder Quint is included in the purposes for which the Capital Reserve Fund was established by the Irondequoit Fire District;

NOW, BE IT RESOLVED, THEREFORE AS FOLLOWS:

1. That the Irondequoit Fire District now appropriates from the Capital Reserve Fund, a sum not to exceed one million seven hundred eighty-three thousand two hundred fifty dollars and no/100 (\$1,783,250) for the purchase of a new 2028 Pierce Enforcer 105' Heavy Duty Ladder Quint.
2. That this Resolution, shall, before becoming effective, be subject to a permissive referendum. That within ten (10) days after its adoption, the District Secretary, and in the same manner as is provided for notice of the annual election, shall publish notice of the passage of this Resolution in the official newspaper of the Irondequoit Fire District. Such notice shall specify the date of the adoption of the resolution, an abstract of the resolution, and shall specify that the resolution was adopted subject to a permissive referendum.

3. That this Resolution shall not take effect until thirty (30) days after its adoption, or until approved by an affirmative vote of the majority of the duly qualified voting electors of this Fire District if a petition, as prescribed by Section 6-g of the General Municipal Law, is duly filed with the Secretary of this District protesting against such Resolution and requesting a referendum as is prescribed in said section of said law.

On roll call vote, the following vote was recorded:


AYES: Commissioners Ange, Ingersoll, Lipari, and Napoli.

NAYES: None.

ABSENT: Turner.
